CIRCULAR No - 47

Sub - Jails – Accounts – Enhanced rate of Services charges – Complying of Government order -reg-

- Ref- 1. Govt. D.O.Letter No.81272/RMC1/2014/Fin dated 30.09.2014.  
2. G.O.(P) No.409/2014/Fin dated 23.09.2014.

The Government have revised the user charges / fees in all Government Departments to maintain minimum standard of service rendered by the Government vide G.O. referred second. Accordingly the rates of user charges / fees (other than educational fees) under the Revenue Receipts Heads of Account from "0051 to 1475" are revised with effect from 01.10.2014 onwards.

While fixing the revised rate in any specific item of Non Tax revenue, it may be ensured that the revised rate fixed in each slab shall not be less than the maximum amount fixed for the preceding slab. The rates shall be calculated after rounding off the amount to the nearest higher rupee.

You are requested to make necessary arrangements to display the revised rate specified in the G.O. on your office notice board for information to the public (copy enclosed). Any laxity on compliance of the Government order and any shortfall in revenues owing to collection at the previous rates prior to this revision will be the personal liability of the officer who has to collect the amount.

The Tax, Non tax revenue Statements should be furnished to this office before 5<sup>th</sup> of every month without fail. Any laxity in this regard will be viewed seriously and the allotment should not be granted.

ORDER

The State Government has been realizing various fees/user charges in connection with various services/facilities rendered by Government Departments in the State. Major Non Tax Revenue items in Government Departments are Various Fees, Fines, Service charges, Receipts under various Acts, Sale proceeds/cost of various form / applications/ documents/ publications/ manufactured/ agricultural products, Rents, User charges for using Government utilities/amenities, Receipts from patients for hospital and dispensary services, Hire charges, Examination fee of Kerala Public Service Commission, Traffic Fee/ Fine receipts, Royalties etc.

2) A revision of same is highly essential at this point of time to maintain minimum standard of service rendered by the Government. Government have therefore decided to enhance prevailing user charges / fees in all Government Departments (other than educational fees / charges) as detailed below. Accordingly the rates of user charges/fees under the Revenue Receipts Heads of Account from 0051 to 1475 are revised at the following rates with effect from 01/10/2014 onwards.

Existing Fee / Charge	Rate of Revision suggested
Up to and including ₹ 10	No revision
More than ₹ 10 – ₹ 1000	50%
More than ₹ 1000 – ₹ 10000	25%
Above ₹ 10000	15%

- 3) The revision will be applicable only to those items whose rates have not been enhanced after 01/04/2012.
- 4) The rates shall be calculated after rounding off the amount to the nearest higher rupee.
- 5) No separate orders need be issued from the Administrative Department concerned in this regard to effect the enhanced rate.
- 6) All fees administered under the education sector such as tuition fee, special fee, laboratory fee, library fee, magazine fee, athletic fee, hostel fee including rent, electricity charge, water charge collected from students and any charge leviable from schools, colleges, polytechnics, ITI, ITC or any other training institutions in the Government or Aided Sector are exempted from the present revision.
- 7) All Heads of the Departments should monitor the non tax revenue collection on weekly basis and furnish a report to the Additional Chief Secretary (Finance) on 10<sup>th</sup> of every month from November 2014 onwards.
