The candidates are directed to report for duty before the Concerned jail superintendents within 14 (fourteen) days from the date of receipt of this order with original testimonials in proof of qualification, date of birth, Community/Non creamy layer certificate (those who were eligible for community reservation) and two recent passport size photographs. He will also produce a physical

fitness certificate from a Medical Officer not below the rank of Civil Surgeon in Government Service as stipulated under Rule 13 of part I of Kerala Service Rules and as prescribed in GO (P) No. 20/2011/P&ARD dated 30.06.2011, a conduct certificate obtained from a Gazetted Officer and the original of one time verification certificate issued by the Kerala Public Service Commission. The advice of the candidates is subject to Rule 3(C) of the General Rules of the Kerala State and Subordinate Service Rules 1958. The appointment is purely temporary under class (1) of Sub Rule (a) of Rule 9 of the General Rules as provided for in Rule 10 (b) of those Rules (vide GO(P) No. 49/74/PD dated 05/03/1974. The proforma for police verification should be filled up and produced at the time of joining duty.

In the event of discharge from service for want of vacancies, the candidates may either re-register their names in the office of the Public Service Commission/ District Office of Kerala Public Service Commission from where they were advised and get themselves re-appointed on further advice by the K.P.S.C or they may wait for their turns for re-appointment to the post in the department in case they desires to continue as probationer in the post from which they are discharged (vide Govt. Circular Memorandum No.3737/Rules-1/90/P&ARD dated 29.03.1990 and GO (P) No.7/91/P&ARD dated 15.02.1991).

If the candidates fail to report for duty on the aforesaid stipulated time, the appointment will be cancelled without notice.
