Home Department - Granting of special remission to certain categories of prisoners as part of celebration of 'Azadi Ka Amrit Mahotsav', to commemorate the 75th Anniversary of India's Independence in the **second phase** - Premature release of prisoners - Orders issued.

ORDER

Government of India as per the letter read as 1st paper above informed that it has been decided to celebrate 'Azadi Ka Amrit Mahotsav' as a series of events, to commemorate the 75th Anniversary of India's Independence and as part of the celebrations, it is proposed to grant special remission to certain categories of prisoners in accordance with the guidelines and timelines issued by the Ministry of Home Affairs in three phases. As per the Government Order read as 4th paper above 33 prisoners were released in the first phase. The second phase of

release has to be completed by 26th January, 2023.

2) As per the direction of Ministry of Home Affairs a State Level Screening Committee consisting of (i) Additional Chief Secretary, Home & Vigilance Department - Chairman, (ii) Secretary, Law Department - Member and (iii) Director General of Prisons and Correctional Services - Member Secretary has been constituted as per the Government Order read as 2nd paper above, to examine cases of eligible prisoners satisfying/ fulfilling the conditions stipulated by the Ministry of Home Affairs.

3) Government, vide order read as 3rd paper above, have further constituted a Sub Committee comprising the Additional Law Secretary (Chairman), the Joint Secretary, Home Department (Convener) and the Deputy Inspector General of Prisons (Head Quarters), (Member) to examine the records of all prisoners to be enlisted by the Director General of Prisons and Correctional Services in this regard and to identify the eligible prisoners who satisfy the prescribed conditions for remission after considering each case in detail and to submit recommendation to the State Level Screening Committee.

4)The Director General, Prisons and Correctional Services, vide letter dated 07.11.2022 read as 5th paper above, has submitted a proposal consisting of 69 prisoners who were found eligible as per the guidelines of Ministry of Home Affairs. The Sub Committee met on 16.11.2022 and 23.11.2022, after examining each case in detail, has submitted its report recommending 40 prisoners for release to the State Level Screening Committee for consideration. The Screening committee held on 17.12.2022 examined the report of Sub Committee and found that all the 40 prisoners recommended by the Sub Committee satisfy the prescribed conditions for remission. Hence the State Level Screening Committee decided to recommend 40 prisoners who are found eligible as per the guidelines to the State Government to provide the benefit of special remission scheme.

5) Government have examined the matter in detail and are pleased to grant premature release to the 33 prisoners mentioned below, after remitting their remaining period of

sentence in exercise of powers conferred under Article 161 of the Constitution of India, subject to the conditions laid down in Rule 470 of Kerala Prisons and Correctional Services (Management) Rules, 2014 and as part of celebration of 'Azadi Ka Amrit Mahotsav' (75th Anniversary of India's Independence) in the second phase.
