### ORDER

As per rule 462 of Kerala Prisons and Correctional Services (Management) Rules, 2014 Jail Advisory committees were constituted in each Central Prison, Open Prison, Prison for Women and High Security Prison to make recommendation for the premature release of prisoners.The Jail Advisory Committee of Open Prison and Correctional Home, Nettukaltheri held on 16.12.2022 recommended 15 prisoners for being granted premature release.The Director General, Prisons and Correctional Services has furnished a copy of the minutes of the meeting and relevant materials vide letter read as 2nd paper above.

2) Government have examined the matter in detail and are pleased to release the following prisoners after remitting their remaining period of sentence, in exercise of powers conferred under Article 161 of the Constitution of India and subject to the conditions laid down in rule 470 of the Kerala Prisons and Correctional Services (Management) Rules, 2014.
